



Co-Curricular Activity Policy for DYPIU

Introduction

Co-curricular activities play a vital role in the holistic development of students at D. Y. Patil International University (DYPIU). This policy outlines the principles, objectives, and guidelines for the planning, implementation, and evaluation of co-curricular activities within the university.

Objectives

Scope

This policy applies to all co-curricular activities organized or endorsed by DYPIU, including but not limited to:

- Student clubs and organizations
- Sports and fitness programs
- Cultural events and performances
- Workshops, seminars, and conferences
- Community service and outreach initiatives
- Entrepreneurship and innovation competitions

Principles

DYPIU is committed to upholding the following principles in its co-curricular activities:

- **Inclusivity:** Ensure that co-curricular activities are accessible and inclusive of all students, regardless of their background, interests, or abilities.
- **Student-Centeredness:** Prioritize the interests, needs, and preferences of students in the planning and implementation of co-curricular activities.
- **Diversity:** Offer a wide range of co-curricular opportunities that cater to the diverse interests and talents of students.
- **Learning Outcomes:** Align co-curricular activities with specific learning outcomes related to personal development, leadership skills, social responsibility, and career readiness.
- **Safety and Well-being:** Ensure the safety and well-being of participants by implementing appropriate risk management measures and providing necessary support services.
- **Collaboration:** Encourage collaboration and partnership between students, faculty, staff, alumni, and external stakeholders in the planning and execution of co-curricular activities.

Guidelines

- **Approval Process:** All co-curricular activities must be approved by the designated authority within DYPIU, ensuring alignment with institutional objectives and compliance with relevant policies and regulations.
- **Student Leadership:** Empower students to take leadership roles in organizing and managing co-curricular activities, fostering a sense of ownership and responsibility.
- **Faculty Support:** Provide guidance and mentorship to student organizers, and encourage faculty participation in co-curricular activities as advisors, coaches, or mentors.
- **Infrastructure and Resources:** Allocate sufficient resources, including facilities, equipment, and funding, to support the planning and execution of co-curricular activities.
- **Assessment and Feedback:** Regularly assess the impact and effectiveness of co-curricular activities on student learning and development, using feedback from participants to inform program improvement.
- **Promotion and Recognition:** Promote awareness of co-curricular opportunities through various communication channels and recognize student achievements and contributions through awards, certificates, or other forms of acknowledgment.

Implementation

The implementation of this policy will be overseen by a designated committee or office

responsible for co-curricular activities at DYPIU. This committee will be responsible for coordinating, monitoring, and evaluating co-curricular activities and ensuring compliance with this policy.

Review and Revision

This policy will be reviewed and updated as necessary to reflect changes in university operations, technology, or regulatory requirements.

Approval and Implementation

This policy is approved by the competent authority. All members of DYPIU are required to familiarize themselves with this policy and adhere to its guidelines.
